2024-2025 Tuition Rates

Enrollment Fee per Student: \$750 per child

This fee is in addition to the annual tuition and places your child on the school roster. This fee reserves a student's place at FCA and enables the school to make financial commitments for the upcoming school year. Enrollment fees are non-refundable and due at the time of registration.

Annual Tuition: \$8,500 *

This fee is for the instruction of your child. Please see the attached tuition and fees schedule for details on the monthly tuition after the Florida Tax Credit scholarship has been applied. Please note: these numbers are an estimate based on Step Up award amounts. If your award amount is different or you are not approved for the scholarship, your monthly payment amount could change. Those who are self-pay without scholarship would pay \$850 per month August-May.

*If your child is awarded the Family Empowerment Scholarship for Unique Abilities, a meeting to discuss your student's specific needs and accommodations will be necessary.

*Tuition is due on the 1st day of the month. A \$5 late fee will be charged each day thereafter. All billing is done through our online FACTS system.

*Additional expenses may be incurred for incidentals such as field trips, testing, uniforms, activities, extended-day services, etc.

If it becomes necessary to withdraw your child from FCA, we require that the parent submit a 60-day written notice to the office and administration. All payments must be paid up to date at the time of withdrawal. In the event a student leaves without a 60-day written notice, parents must submit tuition fees for the following months. A withdrawal form must be filled out and submitted to the school office. If withdrawal takes place at the end of the quarter, Step Up may not pay the balance due. In the event that Step Up does not pay the balance due, parents would be responsible for paying the remaining balance.
